### **STORAGE**

Vehicle POFs Storage: Personnel temporarily residing in Fam Camp may store their POFs in a locked container or cabinet inside a locked camper/motorhome. Unloaded POFs may be stored in a locked container and in a locked vehicle during short stops (commissary, medical, base exchange, etc.). Active duty and DoD civilians may temporarily store unload POFs in a locked container and in their locked vehicle during the workday. Visitors or non-assigned personnel having access to the installation and staying in base housing or billeting will store their firearms in an authorized storage facility.

Base Housing POFs Storage: All firearms will be unloaded/secured in an appropriately constructed locked container, safe or equipped with a tamper resistant mechanical lock or other safety device. Cabinets constructed with glass will have an additional level of security (i.e., trigger locks, wire mesh, etc.). Mechanical locks or other safety devices will be properly engaged to ensure the firearm is rendered inoperable by an unauthorized user. Keys and combinations for mechanical locks and/or other safety devices must be closely controlled.

## **Dormitories/Billeting:**

Storage of Privately Owned Weapons Other than Firearms in Installation Dormitories.

(1) CDMO will provide the dormitory residents with a secure storage area for storing of POWs, other than firearms, and other dangerous instruments.

### PROHIBITED FIREARMS.

The following firearms shall not be possessed, stored, transported, or maintained within the confines of MAFB (Note: Open carry of POFs is not authorized on the installation or property):

- 1. Zip guns or any homemade device, to include 3D printed weapons, capable of firing live ammunition.
- 2. Shotguns having a barrel length of less than 18 inches and/or overall length less than 26 inches or a rifle having a barrel length of less than 16 inches and/or overall length less than 26 inches without a proper federal firearms permit to possess such a weapon. A firearm not specifically manufactured for a compact purpose must not be altered for compactness in a manner that violates the intent of this paragraph; for example: sawing off a stock or barrel or shortening a barrel length by machining or cutting.
- 3. Any firearm that is capable of firing in a fully automatic mode. Gun collectors with proper federal permits may store or register automatic weapons as prescribed for other POFs. All appropriate permits must accompany such weapons whenever they are transported, possessed, or stored on MAFB.
- 4. Any firearm that violates any federal, state, or local law.
- 5. Blackjacks, brass knuckles, Nunchaku fighting sticks, Billy clubs, studded fighting gloves, or any other instrument whose obvious purpose is to be used as a weapon, such as a sawed-off weighted pool cue.
- 6. Sword canes, "throwing stars," throwing knives, or any switchblade knife (regardless of the length of the blade).



# Registration of Privately Owned Firearms / Weapons

- Individuals storing POFs on MAFB, to include military Family housing, will complete the registration within (10) ten days of moving onto the installation.
- Complete an AF IMT 1314, Firearms Registration, to document the weapons stored. Multiple forms may be used if the number of weapons exceeds the forms allotted spaces.
- Complete a DD Form 2760, Qualification to Possess Firearms or Ammunition, a copy will be turned in during initial registration.
- These forms can be obtained through Air Force E-Pubs <a href="https://www.e-publishing.af.mil/">https://www.e-publishing.af.mil/</a> or by Emailing <a href="john.green.53@us.af.mil">john.green.53@us.af.mil</a> and requesting them.
- Forms will be turned into the 341st Security Forces Squadron, Reports and Analysis office located in Bldg. 295 (circled below on the map), Monday thru Thursday 0800-1600 hrs.

# <u>Transportation of Privately</u> <u>Owned Firearms / Weapons</u>

- Transportation of POFs on base is limited to Active Duty, Retired Military, DoD Adult dependents and DoD Civilians. All other personnel are not authorized to transport POFs on the installation.
- Weapons transported on/off base will be unloaded, secured in a truck/rear most compartment of the vehicle out of reach with ammo stored separately.
- POFs may be transported on motorcycles, bicycles, or any other two-or three-wheeled vehicles if the firearm is unloaded and placed in a locked compartment. Firearms must be cleared and safed, and it is recommended they be equipped with a tamper-resistant mechanical lock or other safety device. Firearms will not be stowed in any such manner as to appear to be concealed, e.g. under seats or partially hidden.
