MEMORANDUM FOR ALL MISAWA AIR BASE PERSONNEL

SUBJECT: Authorized Patrons at Misawa AB Dining Facilities

1. IAW AFMAN 34-240, Food Service Program Management, the Air Force operates Appropriated Fund enlisted dining facilities in order to provide the subsistence entitlements to enlisted members who resides in dormitories, to provide a training environment for food service personnel to meet our war-fighting mission, and to provide flight meal service in support of daily operations.
2. With the exception of Active Duty Essential Station Messing customers, all other personnel categorized below will be required to use cash or card for the cost of their meals. In addition, personnel must have appropriate access to the Flight Line in order to dine at the Falcon Feeder.
3. The following personnel may dine at Grissom and Falcon Feeder (with appropriate access):

Enlisted personnel not receiving either an allowance for subsistence or the meal portion of per diem.	X		
Deployed or TDY members serving on an official duty who are not receiving meal portion of per diem and who are not included in ESM who have orders with it explicitly written that meals will be provided by the government.	X		

** Standard rate includes a 33% surcharge. Individual prices on specialty items may vary.

4. The following personnel may dine at the dining facilities in the following circumstances:

a. Youth Groups hosted by DoDEA for officially sanctioned activities may dine at Grissom Dining Facility provided advance coordination with the Food Service Officer or Food Service Section Chief in order to receive the discounted rate.

b. Distinguished Visitors (DVs) to include civilian, military personnel, or foreign government personnel identified by the 35 FW/CC, 35 FW/CCP, 35 MSG/CC, or 35 FSS/CC.
