MEMORANDUM FOR ALL PERSONNEL

SUBJECT: Authorized Dining Facility Patrons

1. The Dining Facility and Flight Kitchen on Davis-Monthan AFB, are supported by appropriated funds and IAW AFI 34-239, attachment 3, paragraph A3.1, "The Air Force operates Appropriated Fund enlisted dining facilities in order to provide the subsistence entitlement to enlisted members who reside in dormitories, to provide a training environment for food service personnel to meet their warfighting mission, and to provide flight meal service in support of daily operations. Generally, use of dining facilities is restricted to enlisted members and those individuals authorized by the installation commander to meet mission requirements."

2. In accordance with AFI 34-239, attachment 9, *Food Service Management Program*, the following personnel are authorized to dine at the Dining Facility and Flight Kitchen.

a. All enlisted members

b. All Commanders/designated members who lead military personnel receiving essential messing (meal card) in order to evaluate the quality and quantity of food service and will pay the standard rate when consuming a meal at either facility. Visits should vary to include all facilities and meal periods, as well as document each visit in the commander's visit log located in the DFAC Manager's office and record their assessment of the facility on the food service comment cards. The Roadrunner and Desert Inn dining facilities are not authorized as a primary dining option for Commanders/Officers.

c. Officers/DoD Civilians in a TDY status to DMAFB receiving the meal portion of per diem.

d. Reserve and Guard units, ROTC/Civil Air Patrol youth groups, and foreign military personnel with prior coordination from the Facility Managers.

e. On-duty volunteers for the Red Cross (must present Red Cross ID badge).

f. Spouses and dependent children of active duty military in PCS status, E1-E4, for breakfast and dinner meals.

g. Spouses and dependent children of active duty military personnel deployed in support of an overseas operation for dinner meal during monthly sponsored programs at the Desert Inn dining facility.

h. All active duty personnel, retirees and their immediate family members on federal holidays, Easter, weekends and the Air Force's Birthday.

i. Emergency personnel/mission essential personnel during base recovery efforts, to include, Customs and Border Protection, FBI, Tucson Fire Department and Tucson Police Department personnel.

3. Additional individuals and organizations will be considered on a case-by-case basis if it is in the best interest of the Air Force, balancing the availability of food services and the impact to primary users.

4. This letter supersedes all guidance referencing Authorized Dining Facility Patrons for Davis-Monthan AFB.
