## **Eglin Recreational FAMCAMP Rules**

Rules/Regulations are subject to change without prior notice. There is a NO TOLERANCE policy, and we reserve the right to remove guests that do not abide by the rules. Air Force Campgrounds were developed for and will be managed to support recreational camping purposes. They are not to be used as a place to live. If space is available guests may reserve for long term stay as long as the guest complies with maximum length of stay.

**RESERVATION POLICY:** Must be Active Duty, Retired Military, Military Dependent, DoD Civilians, Contractors, and 18 years of age. **Reservations must be reserved by the individual that will be occupying the site**. Only one reservation can be made per household (married couples are counted as household). Campers **MAY NOT** hold a site for themselves or friends. Holding a site will result in you and your friends being asked to leave the FAMCAMP. **The campground reserves the right to relocate reserved sites**.

**CHECKIN/CHECKOUT:** Check out time is 1200hrs and Check in time is 1500hrs. Guests must have all items cleared of site by 1200hrs. Early check in or late check out could result in an additional fee, and refusal of payment will result in denial of any future reservation requests until payment is received by the FAMCAMP office.

**CANCELLATION POLICY/REFUNDS:** All site rentals require a nonrefundable deposit of \$80 for guests staying 30 nights or less and \$100 for guests staying 31 nights or more. Reservations less than 30 nights will require full payment at time of booking. Guests have up to 48 hours before the reservation start date to cancel. If a refund is warranted, the guest will be issued a refund or household credit for the reservation amount minus the deposit. Guests that cancel within the 48 hours prior to reservation start date will not be issued a refund. During your stay, refunds will only be given for; a change in orders, being deployed, moving into a house during PCS, evacuation, medical emergency of registered guest, or death of registered guest or immediate family member. Refunds will not be given for unused days.

**QUIET HOURS:** All guests must observe quiet time from 2200-0700. The use of generators or other loud equipment is prohibited during these times. Stereo/TV volume should be kept low enough not to disturb your neighbors. Vehicles with loud exhausts are not to let idle and are to follow quiet hours. The use of generators when there is no power is acceptable.

**CHILDREN UNDER THE AGE OF 10: Must have an adult present when playing outside**. No child(ren) should be running around the campground without an adult in their presence. Children should refrain from playing in roadways, woods, or in other guest's sites. Children are not allowed to take garbage to the dumpster by themselves. Children riding bikes are to be wearing helmets and have proper headlights, indicator lights, or reflective gear when riding during evening hours.

**STAY:** Maximum length of stay at the Eglin FAMCAMP is 120 nights, 30 nights at Postl Point, and 30 nights for tent sites. Once a guest has reached 120 nights, they must exit the park for 30 days before making another reservation. All long-term guests (guests staying 30 nights or more) are to make payment every 30 days. If payment is not paid on due date, this will be considered a late payment. Guests will then have one (1) day to make payment before a \$30 late fee will be added for every late payment day. After two (2) late payments during your stay or three (3) days of non-payment, you will be required to vacate the FAMCAMP. Under unique circumstances, an exception to policy may be granted and requests are to be routed through Force Support Squadron leadership.

MAIL: Do not use the FAMCAMP office as a mailing address. FAMCAMP staff will not accept mail, postage or packages.

TENTS SITES: Two tents are allowed per tent site and must fit within designated area. Tents ARE NOT allowed on an RV site.

**RV SITES:** All RVs must have a National Organization of Alternative Housing (NOAH) or Recreational Vehicle Industry Association (RVIA) certification. Limit of 1 camper and 2 vehicles per site. Vehicles are defined as; truck, car, motorcycle, moped, golf cart, atv, or any other drivable device (kid's toys are acceptable). **Extra vehicles, boats, or utility/cargo trailers are not allowed at Camp Robbins. All vehicles must be parked in the site lane (gravel) at all times**. Vehicles parked on grass or area other than the site lane is not allowed and will be issued a warning. Do not park motorcycles on cement pad. Guests taking their camper off site must take all belongings and site must be clear of personal items. In the event of an evacuation, all campers will be required to depart the park. This includes RV, vehicles, and all personal equipment/items. All guests must have the ability to move their RV (Camper) at all times.

**SITE APPEARANCE:** Guests are responsible for removing trash. DO NOT leave out; any food items, bird feed, garbage, garbage cans, or other items that may attract mice, bears, etc. **Campsite areas must be kept clean and free of clutter** (items such as kayaks, canoes, bicycles, toys, etc. should be stored under camper or present a neat and orderly appearance). All other personal items (ladders, hoses, tools, storage containers, tires, etc.) are to be stored out of sight. No outside refrigerators or freezers are allowed. Coolers left outside must be empty and stored under camper. No poles or large stakes can be driven into the ground. Freestanding canopies,

clotheslines, lattice/or homemade porches/patios, or jungle gyms are not authorized at sites. The only exception is screened-in canopies. Outdoor rugs are only allowed on the cement pad.

**PARKING:** Camp Robbins visitors or guests needing to park an extra vehicle for a couple days (up to five (5) days) can use designated spots located by the FAMCAMP office or parking spots located in front of the restrooms/laundry. Guests parking overnight or for more than a day will need to stop by the FAMCAMP office or see the camp host for a parking pass. Post'l Point visitors or guests are to use the parking lot located by Outdoor Recreation. Do not park in another, or an empty, rv/tent site.

**GRASS CUTTING/TRIMMING:** Long Term guests (guests over 30 days) are responsible for the grass cutting/trimming around their site. Lawn mowers/trimmers are available at the FAMCAMP office for use. The FAMCAMP office will issue a warning if sites are not maintained and after two (2) warnings, you will be asked to vacate the FAMCAMP.

**GRILLING/CAMPFIRES:** Outside cooking is restricted to using propane or charcoal. All charcoal must be dumped in the appropriate dumpster at the front of the campground, NOT in your campsite or woods. **NO OPEN FIRES ARE ALLOWED TO INCLUDE FIRE PITS**. This also includes TIKI torches or any other device that requires an open flame.

**PETS**: Pets must be kept on a leash at ALL times. **Pets cannot be left outside unattended at any time.** First time offenders will be warned. Second time offenders will be asked to vacate the FAMCAMP. Pet waste must be picked up immediately. Dogs are not permitted to annoy others by continuous barking or howling. Pet fences are not permitted at Camp Robbins. Tie-outs that present a safety concern are prohibited. Pets that demonstrate an aggressive behavior may be asked to leave the FAMCAMP.

SPEED LIMIT: 5 MPH. Please be safe and use caution when driving through the campgrounds. Speeding will not be tolerated.

**CONDUCT:** Guests will refrain from irrational behavior to include profanity, threatening gestures, violence, or any other unwarranted behavior. This includes any actions or words deemed abusive towards camp hosts or employees. Guests displaying such actions will be warned and may be asked to vacate the FAMCAMP. Guests are also responsible and accountable for the actions of their children, dependents, and visitors.

Guests are prohibited from modifying the landscaping or natural environment in any manner. **Washing your RV/Camper, vehicle or any other item is prohibited** (water is specifically designed to provide water to your RV and may not be used as a hose or as a toy). Oil changes or other vehicle maintenance is prohibited. Carpentry or woodworking is not allowed. No fireworks and/or firearms allowed on premise at any time. Storing of hazardous material is not authorized.

Swimming is authorized in the bay at your own risk. No lifeguard on duty.

## You must immediately inform the 96<sup>th</sup> Security Forces Squadron at 850-882-2502 and the 96<sup>th</sup> Force Support Squadron Outdoor Recreation Director and/or FAMCAMP Manager before arrival if you or your guests have been convicted or are pending conviction of a drug related offense or are a registered sex offender or predator.

Federal Law regarding medical marijuana or any other illegal drugs: Cannabis is illegal on the national level. This means it is illegal to consume marijuana in its national parks, forests, federal wildlife, and any other federal properties that are under federal law. If you are caught with any type of drugs other than prescription drugs, you will be asked to leave the FAMCAMP and the Security Forces will be notified. Smoking is not allowed in restrooms or laundry facilities or within 50 feet of the entrance to said facilities.

It is your responsibility to adhere to all installation policies while on Eglin AFB. Your stay may be discontinued at any time if a lack of accordance is demonstrated for any of the above-cited responsibilities while you are a guest at our FAMCAMP.

By accepting to stay at Eglin FAMCAMP, you are also accepting to abide by and follow the above rules set forth by Eglin FAMCAMP. Any questions or concerns may be directed to the FAMCAMP Manager or Director.
