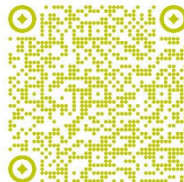

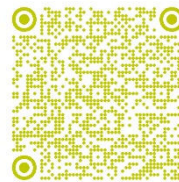

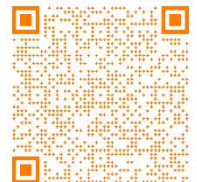

<b>Work Place</b>	18 MSG/DET1, OKU, Okuma Recreation Area	<b>Number of position(s)</b>	1
<p><b>Summary of duties:</b> Operates government automobile motor vehicles such as sedan, pickup truck, SUV and/or Other Government Vehicle to patrol Okuma Recreation Area and other areas to prevent unauthorized entry, theft or damage to government property. Reports incidents and irregularities. Takes predetermined actions complying with general or special orders immediately upon occurrence of emergency situations or possible occurrence thereof, or may take emergency actions using own judgement as the circumstances require. Performs operator's daily inspection maintenance of the assigned vehicle and equipment. Stands guard at designated entrance/exit gates and controls traffic of military and civilian personnel and vehicles entering and leaving USFJ facilities. Issues visitors permits after obtaining clearance for individuals or organizations involved. Under supervision of a US military or Japanese guard supervisor, serves in a desk sergeant capacity performing such duties as receiving and answering telephone calls at the Base Defense Operations Center and relaying messages to the personnel concerned. Receives reports of all incidents, accidents, violations, disorders and other unusual events. Assists the military police desk sergeant in handling routine matters involved in civilian guard activities as required and may act as interpreter between military police personnel and Japanese personnel in case of occurrence of incidents. Ensures Police Blotters and other applicable paperwork are completed by the end of each shift or within a reasonable time after shift end, as directed by shift leader. Perform other related or incidental duties as assigned.</p>			
<p><b>Qualification Requirements:</b></p> <ol style="list-style-type: none"> <li>1. High school graduate or equivalent desired.</li> <li>2. Work experience directly related to sentry duty in armed forces or police department OR two-year work experience as a guard in other organization/office settings.</li> <li>3. Must possess a valid <u>GOJ vehicle driver's license</u> and be able to receive/ maintain a US military driver's license.</li> <li>4. Ability to speak, read and write <u>English at elementary proficiency level: LPL-1 is required.</u> However, a professional working proficiency level of English is desired.</li> </ol> <p><b>Job Related Requirements:</b></p> <ol style="list-style-type: none"> <li>1. No record of conviction for civilian offense other than minor traffic violations</li> <li>2. Must be physically and mentally capable of maintaining a high standard of duty performance.</li> <li>3. Must complete appropriate training/courses as directed.</li> <li>4. Duties require satisfactory completion of appropriate training in use of certain firearms as required and the carrying of such arms while assigned to duty station authorized by the respective authorities.</li> <li>5. Must attend small arms (i.e. M9) weapons firing classes to maintain proficiency/qualification.</li> <li>6. Duties require understanding of and ability to follow routine security procedures.</li> <li>7. Duties require individual to be certified in one of the following less than lethal equipment (TASER, ASP Baton, and/or Oleoresin Capsicum (OC) spray) within 30 days after entrance on duty date. (NOTE: Individuals are not required to be "TASERed" when certifying on TASER)</li> <li>8. Must be able to wear protective equipment weighing less than 15 lbs/6.8 kg for the duration of the duty and/or as directed (NOTE: Protective equipment consists of Kevlar helmet and Kevlar body armor).</li> <li>9. Must be able to work weekends, holidays, any shifts (days/nights).</li> <li>10. May have to work outside of regular shift hours if requested.</li> </ol> <p><b>Special Factor:</b> This position is designated as Mission Essential which requires incumbent to report to duty or continue performing duties during emergencies or exigent situations such as but not limited to natural disasters, adverse weather, terrorist activity, radioactive/poisonous gas release, outbreak of pandemic disease or other events that may present a danger to any USFJ facility, personnel or LN employees, or which require extraordinary USFJ assistance for relief measures. Incumbent in security guard is considered as emergency responders and critical to the mission. As such, the employee would be ineligible for recall to Japan Self Defense Force (JSDF) active duty.</p> <p><b>Work Schedule:</b> Mon-Sun (40 hours per week) 8-hour shift: 0600-1445, 1400-2245, 2200-0645 (Recess: 45 minutes) 10-hour shift: 0600-1700, 1400-0100, 1600-0300, 2000-0700 (Recess: 60 minutes) 12-hour shift: 0600-1900, 1800-0700 (Recess: 60 minutes) NOTE: Work hours very based on manpower and mission requirements.</p>
