## Base Resale Lot Use Agreement

1. The owner hereby agrees to comply with the provisions of 81 FSS/FSWT SOI 34-30.
2. Owner is responsible for the quality and accuracy of all information submitted. Neither Keesler Arts & Crafts Center nor the 81 FSS webmaster bear any responsibility to seek out information missing from this form or to verify information submitted erroneously.
3. Owner hereby expressly assumes the risk of any and all damages; loss or destruction of his/her above described property for and during the time the property is located on the Base Resale Lot, Keesler Air Force Base, Mississippi, together with all property located within or attached to the aboved described property.
4. Owner assumes full responsibility to move his/her property to safety immediately upon receiving warning of impending hurricane, tropical storm or other catastrophe or disaster. In the event the owner cannot be located, he/she hereby authorizes the United States Air Force or its authorized agents to remove property from the Base Resale Lot and to store it as practically as possible under circumstances. The USAF and its authorized agents are not responsible for owner's failure to secure or remove his/her property and are under no duty to act to protect the property in the event that the owner fails to do so.
5. Owner will remove all his/her property from the Base Resale Lot, Keesler Air Force Base, Mississippi, either upon the expiration at the time limit or upon the expiration of the agreed upon time or his/her departure from the local area, the USAF or its authorized agents may remove the property from the Base Resale Lot and dispose of it in accordance with application United States Air Force regulations dealing with abandoned property found on base.
6. Vehicles/Trailers must display current registration on their license plates. A copy of the vehicle's insurance and registration must be provided to the Arts and Crafts Center at registration. Owners are required to turn in updated copies when the copies on file expire.
7. Customer's name must be listed on the registration as the legal owner in order for the Arts and Crafts Center to issue a permit for the vehicle.
8. When registering boats, owners must provide proof of registration on the boat's trailer and provide proof of insurance on the vehicle towing the trailer.
9. Max rental period on the resale lot is ninety (90) days or until the vehicle is sold, whichever occurs first. There will be no exception to renewal of permits without the permission of the Arts and Crafts Director.
