Permission Form for:

Insect Repellent, Sunscreen, Face Pain, Hand Sanitizer and Lotion

1. The Laughlin Child Development Center and Youth Center will apply sunscreen, insect repellent, hand lotion as needed throughout the day to protect children over 6 months of age from sunburn, mosquito bites and dry skin. Hand sanitizer for children 2yrs of age or older (only if water and soap is not available). The programs will provide one option of sunscreen, insect repellent and hand lotion.
2. The base pediatrician has authorized the use of the following sunscreen, insect repellent and hand lotion.
 - a. CDC and YC is Banana Boat Kids UVA/UVB Protection Broad Spectrum SPF 50 or
 - b. Coppertone Water Babies Broad Spectrum SPF 50
 - c. Insect Repellent with 30% DEET/5-10% Picaridin
 - d. Johnson's or Aveeno Baby Hand Lotion
 - e. CleanWell Botanical Foaming or Babyanics Alcohol-Free Foaming Hand Sanitizer
 - f. Professional Face Paint Non-Toxic & Hypoallergenic by Artiparty
3. The base pediatrician has authorized alternate use of the following sunscreens, insect repellents and hand lotion if you wish to provide your own. The use of these products will not require a doctor's note.
 - a. Cutter Naturals or Coleman Skin Smart Insect Repellent
 - b. Babyanics Mineral-Based Sunscreen SPF 50 or Aveeno Baby Sunscreen Lotion SPF 55
 - c. Baby Magic Lotion
4. Parents wanting to bring in their own alternative brand other than what is offered or suggested above will need to supply it to the program with a doctor's letter of recommendation.
