### Important Details for Military Promotional Ticket Offer:

- ★ Up to six tickets may be purchased per year only by Eligible Service Members or their spouses (but not both), for use by themselves and only family members and friends, as provided herein. Tickets may not be transferred, distributed or resold. One of the six tickets purchased must be used and activated by the Eligible Service Member or his/her spouse at Disney World theme park ticket windows.
- ★ "Eligible Service Members" are active or retired members of the U.S. Military, including the National Guard, Reservists and the U.S. Coast Guard, the Commissioned Corps of the Public Health Service (PHS) and the Commissioned Corps of the National Oceanic and Atmospheric Administration (NOAA). Spouses of Military Service Members and PHS and NOAA Commissioned Corps members also qualify if they are able to present valid and active U.S. Military IDs in the absence of the Military Personnel or Commissioned Corps members. Not eligible: Contractors, DoD Civilians, or Veterans with a VA Medical ID Card only (Not 100% Disabled DAVPRM military ID card)
- ★ The MacDill ITT Office requires that Eligible Service Members (or their spouses) present valid military identification to purchase Disney Military Promotional Tickets.
- ★ Download the free mobile app: MyDisneyExperience to make reservations required for park entry.
- ★ These tickets may not be transferred, distributed or resold. Not valid until activated at guest services and must be activated and used by December 20, 2024. NO EXCEPTIONS. Must be used by the same person on any and all days.
