



2024 MACDILL “MWR PASSPORT TO FUN” RULES & ELIGIBILITY

To enter this contest, you must agree to these Official Rules. Please read these Rules prior to completing your passport to ensure you understand and agree. By entering this contest, you agree to abide by these rules.

Participants must register their intent to play at www.macdillfss.com/passport and pick up a free passport book at any participating FSS facility.

Visit each FSS activity to receive stamps for your passport. To obtain a stamp under any visit or services block, you must utilize (ITT/Bowling/Golf/Outdoor Rec/Arts and Crafts/Library/Family Readiness/Dining Facilities/FSS base wide events) services or programs. When your passport is complete (based upon the prize tiers), return it to the MacDill Information, Tickets and Travel office located at 3108 N. Boundary Blvd, Bldg 926, inside the BX Mall to be entered to win no later than 31 Jan 2025.

ELIGIBILITY

Authorized patrons of MacDill Air Force base's 6 Force Support Squadron's Morale, Recreation and Welfare (MWR) Programs (IAW 34-101), Air Force Morale, Welfare, and Recreation (MWR) Programs and use Eligibility) are eligible to participate.

- a. Participants must be 18 years or older at the time of completed entry.
- b. FSS Commanders, Civilian leaders and FSS personnel may enter the passport contest but are NOT eligible to win prizes. These individuals must clearly identify they are ineligible for prizes on the passport form.
- c. All eligibility requirements in these official rules must be met.
- d. Prizes will only be awarded to eligible participants who have registered and completed a passport based upon the prize tiers.
- e. Any passport submission that does not meet all the requirements will be ineligible.

CONTEST PERIOD

This contest will run from 25 October 2024 until 31 January 2025. All completed passports must be turned into the ITT office by 31Jan 2025 and logged to be eligible for prize drawings. Drawings will be held on 7 February 2025.

PASSPORT COMPLETION

The Information, Tickets and Travel office will be the point of contact to turn in completed passports once participants have met the requirements of each participating facility or program. Once passports are completed, the ITT staff will log the participant's entry into the tiered prize packages.

WINNER NOTIFICATION

Winners will be notified via the email address and/or phone number provided on the completed passport turned into the ITT office. This is the only method of communication which will be used to notify winners. If a winner does not respond to the listed methods of communication, an alternate winner will be selected. The winner is subject to passport verification, including without limitation, verification of eligibility, and compliance with these Official Rules.

PRIZES

Requirements:

Visit each Facility and receive a Visit and Learn Stamp; Seven (7) Stamps.

Collect Two (2) Dining Stamps.

Collect Two (2) Event Stamps

Total Stamps for Tier 1 Prize; Eleven (11) Stamps

In addition to the above drawing for gift cards, 6 FSS will have random giveaways throughout the contest based upon email registrations.

Tier 2 Prize: Five (5) drawings for \$250 FSS gift cards

Requirements:

Visit each Facility and receive a Visit and Learn Stamp; Seven (7) Stamps.

Collect Four (4) additional activity services program stamps.

Collect Three (3) Dining Stamps.

Collect Three (3) Event Stamps

Total Stamps for Tier 2 Prize; Seventeen (17) Stamps

In addition to the above drawing for gift cards, 6 FSS will have random giveaways throughout the contest based upon email registrations.

Tier 3 Prize GRAND PRIZE: 1 drawing of a not to exceed \$5,000 Vacation Package from ITT.

Winner may choose one of the offered vacation packages available. No change will be given should the chosen package be less than \$5,000.

Requirements:

Visit each Facility and receive a Visit and Learn Stamp; Seven (7) Stamps.

Collect Eight (8) additional activity services program stamps.

Collect Six (6) Dining Stamps.

Collect Four (4) Event Stamps

Total Stamps for Grand Prize; Twenty-five (25) Stamps

In addition to the above drawing for gift cards, 6 FSS will have random giveaways throughout the contest based upon email registrations.

HOW TO PARTICIPATE

NO PURCHASE IS NECESSARY TO PARTICIPATE OR WIN. To participate, visit: macdillfss.com/passport and follow the instructions by registering, visiting and participating in 6 FSS facilities and programs. One stamp will be awarded per visit or for each service. Stamps may not be “stacked” in the same visit. Once a passport holder has collected a minimum of Eleven (11) stamps by visiting Seven (7) activities, collecting Two (2) Dining Stamps, and receiving Two (2) Event Stamps, they are eligible to enter the Tier 1 prize drawing. Once a passport holder has collected a minimum of Seventeen (17) stamps by visiting Seven (7) activities, gaining Four (4) additional Activity Services Program Stamps, collecting Three (3) Dining Stamps, and receiving Three (3) Event Stamps, they are eligible for the Tier 2 prize drawing. Finally, once a passport holder has collected a minimum of Twenty-five (25) stamps by visiting Seven (7) activities, gaining Eight (8) additional Activity Services Program Stamps, collecting Six (6) Dining Stamps, and receiving Four (4) Event Stamps, they are eligible for the Tier 3 grand prize drawing. Once the passport holder has completed activities in each Tier area of the passport, it may be turned into the ITT office for validation, logged and entry into the various prize packages. Passport holders may complete more than one passport for entry. **LIMIT TWO (2) COMPLETED PASSPORTS PER PERSON.** Subsequent entries will be disqualified. All completed passport entries must be received by 11:59:59 pm (EST) on 31 January 2025.

PASSPORT REQUIREMENTS

- a. By submitting a completed passport, entrant is guaranteeing he/she has met the terms by either visiting or participating in a service in an FSS program or facility and received a stamp for each appropriate visit or service. Incomplete passports may not be combined together for any reason.
