# FamCamp

## Scott AFB Outdoor Recreation

Outdoor Recreation manages the Scott AFB FamCamp located in the Scott Lake Recreation area (base access required). The FamCamp is nestled among the trees providing lots of shade in the summer, and overlooking the two base fishing lakes. The FamCamp has 22 RV campsites, each with water and electric hookups. Restrooms, showers, laundry, and a sewage dump station are available to use on site. RV Sites are either paved or gravel, no pull-through sites are available.



### Scott Lake Fishing Permits

- Individual \$5/year
- Family \$7/year

### Picnic Pavilions

- Pavilions 2, 4-10 \$15/day
- Pavilion 11 \$35/day

### RV Storage

- Short (up to 20 ft) \$27/month
- Long (20 to 40 ft) \$37/month

### POV Resale

Permit required \$15/30 days

## Rates

RV Site (water/electric)	\$25/day
Overflow (no utilities)	\$10/day
Primitive/Tent (no site)	\$10/day

## Reservations

Reservations can be made for 30 days at a time, up to 30 days in advance. Payment is due in full at time of reservation; contact Outdoor Recreation during business hours to complete.

## Cancellations

All cancellations must be made 48 hours prior to check in date to receive a full refund. Cancellations or modifications made less than 48 hours prior to start of reservation will be non-refundable.

## Check In/Check Out

Check in is at 1 pm and check out is at 11 am. Campers are assigned a space and will go directly to the site they are assigned. Upon arrival, a reservation card will be on the site post for their site, showing their last name, site number and dates of stay. The tag must remain on the site post for the duration of the stay. *Site changes may only be made with prior approval of the Outdoor Recreation staff.*

## RV FamCamp Sites

Each site is allowed only one camping unit and one towing vehicle. All structures other than those which are standard for the RV must be approved by the ODR director. Please keep mats off the grass and no vehicle parking on grass between campsites. All tents must be charged a separate Tent Fee per tent. Do not remove picnic tables from designated areas in RV sites.

## Primitive/Tent Camping

Tent camping may be done anywhere in the Scott Lake area except for in the following: RV Sites, Pavilions, Pavilion parking areas, and the Boy Scout Camp. Permit must be picked up from Outdoor Recreation during business hours.

## Overflow

An overflow area is available on a first come, first serve basis for dry camping. No Reservations will be made for this area. Overflow has no hookups.

## One Night Stay

One Night Forms and Dropbox are currently available at the Bathhouse. If arriving after ODR office hours or when office is closed, fill out pink One Night Card and place on Site Post and drop filled out form and payment in Dropbox. For arrivals during business hours, contact Outdoor Recreation before choosing site.

## Pets

We welcome your family pets; they must be on a leash or inside the camper at all times. Please clean up after your pet and put them inside at night. Do not leave unattended. **NO FENCES OF ANY KIND ARE ALLOWED.** Pets are not allowed in the restrooms or the laundry. Pets must be current with all shots and licenses.



## Quiet Hours

11 p.m. to 7 a.m. are quiet hours. Generators must not be operated at night.

## Maintenance

For environmental reasons, no mechanical maintenance (including oil changes) or significant repair work may be performed, and recreational vehicles may not be washed in the recreational vehicle camp.

## Additional Info

- Customers are responsible for keeping their site clean and picked up as well as supervising their children and pets.
- **Laundry** facilities are located in the front of the Bathhouse building and are coin-operated.
- No parking on grass, additional parking may be available near Bathhouse.
- **Fires** allowed only in Grill Grates, do not build fire rings. Discard all unused Firewood when vacating site at end of reservation period.
- **Base Fishing Permit** required for Scott Lakes, purchase from ODR during business hours. Illinois State Permit not required.
- **DO NOT LEAVE ADDITIONAL EQUIPMENT SITTING OUTSIDE YOUR CAMPER IN YOUR CAMPSITE.**
- All belongings must be stored out of sight in your FamCamp site.
- Recreational items (bicycles, non-motorized scooters, games, etc) and must not be left in the roads, unoccupied sites or by the Bathhouse.
