

APPLICATION FOR CIVILIAN BASE ACCESS
to Tinker AFB Golf Course

READ BEFORE FILLING OUT FORM

The Tinker Golf Course is a Department of Defense (DoD) golf course located on a military installation, and allows restricted access for civilian golfers to the golf course ONLY. Base access is a privilege and may be revoked or denied at any time. Always be courteous to our men and women in uniform and security personnel. Inappropriate behavior is grounds for denial and/or removal. All new and renewal requests must follow the procedures below:

Applications may be sent by mail or hand delivered by those with base access. All personal information will be kept confidential and protected under the terms of the Privacy Act. Please fill out the application legibly and completely. Incomplete applications will not be accepted or processed. After submission of an application and processing by the Tinker Golf Course, the application will be delivered to Security Forces. Applicants have 30 days to retrieve their pass from security. Civilian applications are processed only on Friday evenings from 430pm - 730pm, and Saturdays and Sundays from 9am-4pm. Passes for civilian golfers will NOT be processed during normal business hours (Monday-Friday, 6am - 4pm). A background check will be ran when you arrive at security. Please bring **two valid photo IDs** (drivers license or passport), vehicle registration and proof of insurance. **Negative** findings on background checks will result in a denial of access. If you are approved for access to Tinker AFB, security will conduct an interview where conditions and restrictions of base access are reviewed and the applicant is asked to sign a form indicating agreement to the terms and conditions of access.

Once you have your pass you are authorized to use Tinker Golf Course when it is open. You may access the golf course from the EAKER GATE ONLY (I-40 & Town Center Drive), from 7am to 730pm only. You MUST show your pass to the guard at the gate. Any passengers with you MUST have their own pass. After being cleared through the gate, turn right at the first traffic signal immediately onto Arnold Street and remain on Arnold Street for three traffic signals/street crossings, proceed to to the golf course (approximately 1 mile on the right) for use of the facility. When use of the facility is completed, you must use the same route to directly exit the base. Any deviation from this route may result in the loss of base entry privileges.

All personnel and their property are subject to search while gaining access to or on Tinker AFB. Seat belts must be worn at all times while on base. Talking or texting on a cellular phone while operating a motor vehicle is prohibited. Fire arms are not permitted on the installation, even with permit to carry. Always stop for pedestrians. Always have your access badge on your person and be prepared to present it when asked. All personnel must follow Air Force and golf course policies while on base. Please see the Pro Shop for information on policies, rates and tee times procedures. Foreign nationals are not permitted access at this time.
