



## CAMPGROUND POLICIES

- Campers **MUST** use a water pressure regulator attached to faucet end of hose due to very high water pressure in the campground.
- No bird or animal feeders allowed, as they attract bears.
- Children under 12 must be accompanied by an adult at all times.
- Helmets must be worn when riding bikes on the base.
- Limit of two vehicles and one tent per RV site.
- Limit of eight people per site (both tent and RV sites).
- Sponsors are responsible for the safe and proper conduct of their dependents and guests at all times.
- Quiet hours: 10 pm-7 am.

## PET POLICY

- Must be on a leash at all times or in a pen/leashed and accompanied at all times when in the campground, **NO EXCEPTIONS**.
- No more than four pets per site.
- Pets must never be left outside without owner present. Visual accompaniment from RV is not permitted.
- Pickup after pets **IMMEDIATELY**, no exceptions, doggie bags provided throughout campground as a courtesy.
- Pets are not allowed in restrooms or office.
- Barking must be kept to minimum.
- Must be registered at the Vet clinic if stay exceeds 2 weeks, 719-333-4055.

## FIREARMS POLICY

FIREARMS ARE NOT PERMITTED ON THE AIR FORCE ACADEMY GROUNDS. All firearms must be declared at the time of entry into USAFA. Firearms must be taken to a secured location until the time that the owner departs the Air Force Academy.

## RESERVATIONS

- Active Duty members may make reservations 90 days in advance.
- All other eligible users may make reservations 60 days in advance.

## ELIGIBILITY

- Cadets/Preps, Active Duty and Retired Military, Reserves, Guard, 100 % DAV, VHIC vets, and categories covered in the USAFA Instruction 34-103.
- Contractors are not eligible users.
- AOG ID card holders are authorized to make reservations up to one year in advance for alumni events. Must be an AOG member with an ID card or have proof of AOG sponsorship. Length of stay may not exceed seven days.

## NON-MILITARY GUEST

*(DoD ID card holder must be present to fill out paperwork)*

Cadets may make reservations up to one year in advance of graduation and parents weekend for their parents. Alumni graduates will be supported as Priority 23 customers. Fees and charges will be at a higher rate than eligible Active Duty, retiree, and DoD members. Usage of Cat C Activities will be limited to the visiting hours 9 am - 5 pm, due to base access hours established by Security Forces.

Sponsored guests are permitted to stay at the campground during non-holiday times and are limited to 14 days per calendar year. Sponsors must be present to check guests in and all guests must have a visitor pass for the base prior to check in. Guests are not permitted to stay in the campground on the following dates:

May 23 – May 29

July 2 – July 8

Aug 29 – Sep 4

Oct 10 – Oct 16

## NOTE: GUEST ARE BASED UPON CURRENT SECURITY PRECAUTIONS.

AOG and VHIC members are not permitted to bring additional guests onto the installation. The USAFA FamCamp does not sponsor guests. Base Entry passes will be required from Security Forces at check-in for overnight stay of guests.



## PEAK SEASON PRICES • RV SITES

### (APRIL 1 – OCTOBER 31)

- \$39 per night - 27' and under
- \$44 per night - larger than 27'
  - (30 nights max stay during peak season for DoD ID card holders)

All patrons MUST bring RV registration at check-in time.

## TENT SITES

\$18 per night, valid DoD ID card holders.

## SPONSORED GUESTS\* & VHIC

(\*DOD ID card holder must be present to sign in)

\$44 per night - 27' and under

\$49 per night - larger than 27'

\$23 per night - tent site

All patrons MUST bring RV registration at check-in time. Sponsors MUST make a reservation and be present at check-in. (14 nights max stay for guests and VHIC during the calendar year.)

## OFF-SEASON PRICES

### (NOVEMBER 1 – MARCH 31)

- Winter RV camping in sites 41 - 105 only.
- No tenting, no sleeping in vehicles or truck beds.
- Active/retired military, DoD and 100% DAV.
- Daily rate: \$35 per night.
- Monthly rate (begins on 1-5th of each month only): \$800
  - If arriving outside of the 1st of the month, use daily rate.
- Late payments are assessed at \$10 per night.

## WINTER STORAGE RATES

*(For military ID card holders only)*

- Storage in sites 1-40 only — no camping while in storage.
- Storage agreement signature required (in packet).
- Monthly rate (begins 1st – 5th of each month only)
  - Monthly rate without electric plug-in: \$60
  - Monthly rate with electric plug-in: \$140
  - Daily rate without electric plug-in: \$6
  - Daily rate with electric plug-in: \$8

**ID CARD & RV/CAMPER REGISTRATION MUST BE PRESENTED AT CHECK-IN. RANDOM ID CARD CHECKS WILL ALSO BE COMPLETED WEEKLY.**

*IAW AFI 34-101 - Max 180 days per calendar year, NO EXCEPTIONS will be made to the AFI.*
